Texas Rising Star



Texas Rising Star is the statewide Quality Rating and Improvement System (QRIS). Programs that are Texas Rising Star certified are considered programs that have a commitment to quality care and improvement that exceeds the state's minimum licensing standards. The Texas Rising Star program offers three levels of quality certification (Two-Star, Three-Star,

and Four-Star) to encourage child care and early learning programs to attain progressively higher levels of quality. Find more information <u>here</u>!

Child Care Services



The Texas Workforce Commission (TWC) <u>child care services program</u> subsidizes child care for lowincome families, promoting long-term self-sufficiency by enabling parents to work or attend workforce training or education activities. TWC also provides resources to educate parents about the availability of quality child care, which enhances children's early learning. To serve families in the CCS program, providers must have a provider agreement with their local Workforce Solutions office to provide child care services. Texas Pre-K Partnerships

PRE-K PARTNERSHIP EXPANSION INITIATIVE

A prekindergarten (pre-k) partnership is a collaboration between a quality-rated child care program and a school district or charter school. Eligible children are dually enrolled in public school pre-k and TWC's Child Care Services program.

Pre-k partnerships are an opportunity for child care programs to increase and/or maintain their enrollment, improve their financial stability, and access shared resources and professional learning opportunities. TWC covers the cost of wraparound care for eligible children in pre-k partnership classrooms. In addition, school districts/charter schools may pass through state funding to the child care program to assist with the costs of pre-k instruction. Apprenticeships



A Registered Apprenticeship Program is a federally recognized career pathway and offers an opportunity for child care providers to recruit, train, and retain high-quality staff. Child care apprentices are full-time paid employees who "earn while they learn" by combining on-thejob training with educational instruction that leads to a nationally-recognized credential. For

Child and Adult Care Food Program (CACFP)



The CACFP is a nationwide program administered by the United States Department of Agriculture (USDA) and the Texas Department of Agriculture (TDA) that provides approved child care centers and home-based providers with financial resources to afford nutritious meals and snacks for the qualified children they serve. The additional financial resources cover a portion of the provider's existing food costs, children served in the program will have access to well-balanced, nutritious meals, and parents save time and money by not having to buy, prepare, or pack meals at home. Business Development Program



Collaborative for Children's Business Development program offers free interactive business training sessions for child care owners and directors statewide. Trainings are offered both inperson and virtually and are designed to enhance business practices, sustainability and provide preparation for seeking Texas Rising Star certification.

Skills for Small Business



The Skills for Small Business program is designed to help employers with fewer than 100 employees access training for full-time staff. This program offers reimbursements to child care providers whose staff sign up for specialized training provided through an

approved community or technical college, or through the Texas A&M Engineering Extension Service. A total of \$1 million has been approved to allow child care businesses to participate in this program!

Child care providers with fewer than 100 employees are eligible for a reimbursement of up to \$900 per existing worker, and up to \$1,800 per newly hired worker. For more information on this on-going opportunity, visit the Skills for Small Business for Employers webpage.
